1 Definition of the Egyptian Drug Database

The Egyptian Drug Database is a search engine displayed on the website of the Egyptian Drug Authority. This database displays information about all valid registered pharmaceutical products in Egypt. It serves as a comprehensive resource for healthcare professionals, pharmacists, and the general public to verify the registration status, composition, and other relevant details of pharmaceutical products available in the Egyptian market. Additionally, the database ensures the long-term safekeeping of data without deletion, preserving the integrity and availability of information over time.

2 Search Criteria

The database includes information on all types of products, such as:

- Human Pharmaceutical: Medicines intended for human use.
- Biological: Products derived from living organisms, including vaccines and blood products.
- Herbal Medicine: Medicinal products made from plants.
- Veterinary: Drugs intended for animal use.
- Biocides: Substances that can destroy living organisms.
- **Cosmetics:** a preparation (as a cream, lotion, or powder) used to improve a person's appearance
- Complementary: Products used alongside medicine.

3 How to Search the Database

To search for a specific drug type, follow these steps:

- 1. **Select Drug Type**: Choose one of the drug types listed above (e.g., Human Pharmaceutical, Biological, Herbal Medicine, etc.).
- 2. Enter Search Fields: Input one or more of the following fields to refine your search:
 - **Trade Name**: The brand name of the drug.
 - Registration Number (Reg No.): The official registration number of the drug.
 - Applicant: The name of the entity that applied for the drug registration.
 - Generic Name: The common name of the drug's active ingredient.
- 3. Enter Verification Code: Complete the verification process by entering the displayed code.
- 4. **Press Search**: Click the search button to retrieve the relevant information from the database.
